



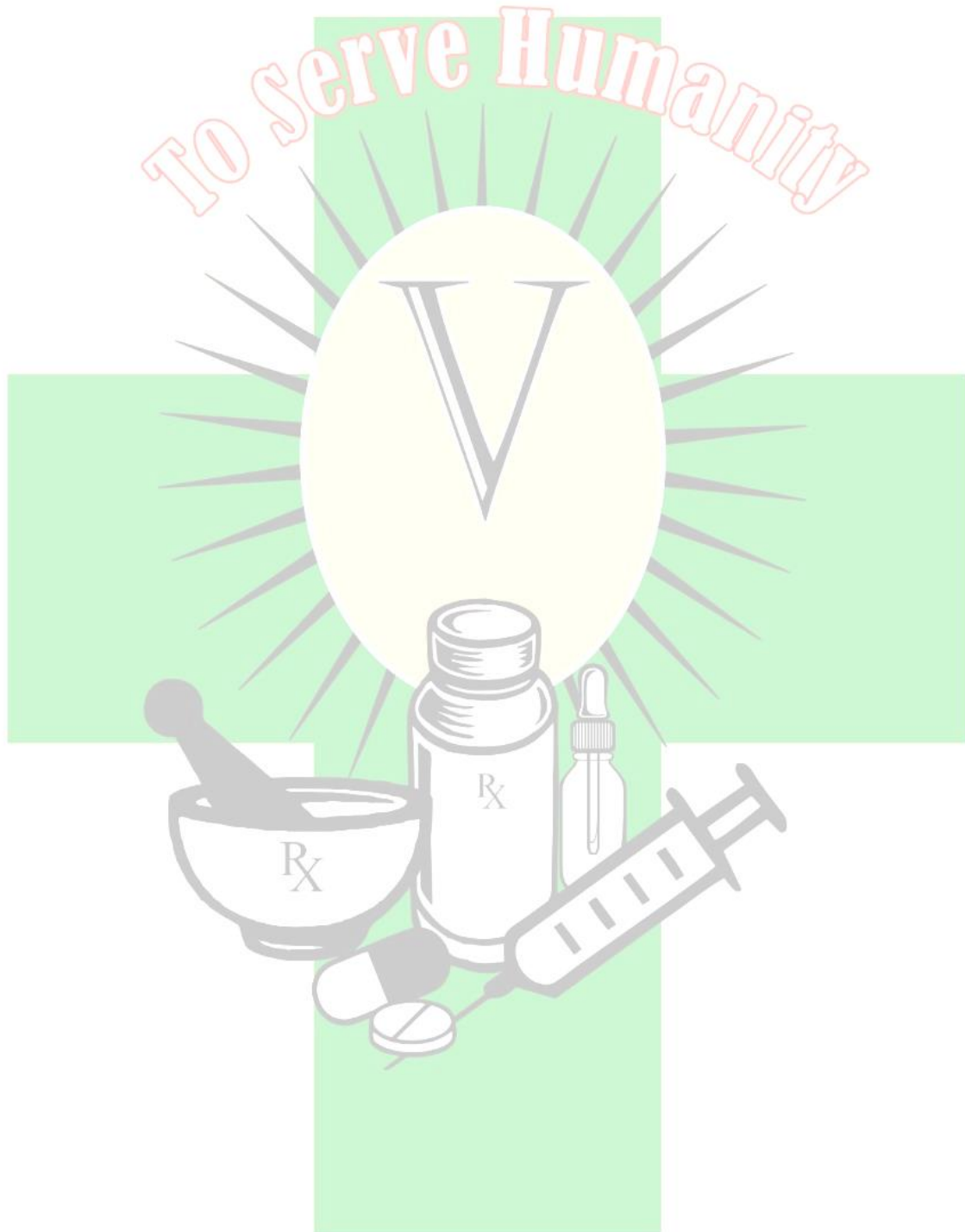

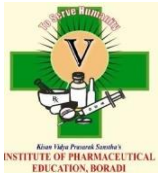
Instructions to Paper Setters

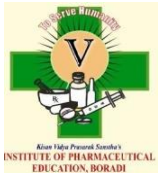

Examination Pattern

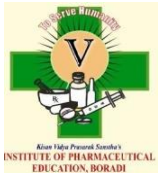
All the examinations of the Degree Courses are conducted semester pattern. For B Pharm and M Pharm course (2017 PCI semester pattern), 25% marks are reserved for internal Sessional examination and 75% marks for the University examination; 20% marks for internal sessional examination and 80% marks for University examination. Novel examination system, for evaluation purpose the college has developed a model examination system characterized by confidentiality, impartiality, accuracy and speed. Its silent features are as follows:

- For each subject, three sets of questions papers covering the 80% syllabus are set from which only one set is selected by the principal for conducting examinations. While others sets are retained in the safe custody.
- The confidential center wise mechanism has been evolved to print, delivered store and used examinations related materials and collect the same for safe custody.
- In the internal examination, we provide 24 pages for a paper with no section and supplements. At the examination center, Jr. Supervisor should confirm all the entries on the front page of the answer book and seat number (roll number) of the candidates. Instruction for a candidate and Jr. Supervisor are displayed outside the exam department on flex. After the examination, the answer books are collected at examination department.

Answer books of different divisions are prepared and the bundles are kept ready for assessment. After assessment the comparative marks statements of each divisions are display on the notice board. This method is helpful for more transparency in exam and reduces chances of malpractices at different levels.

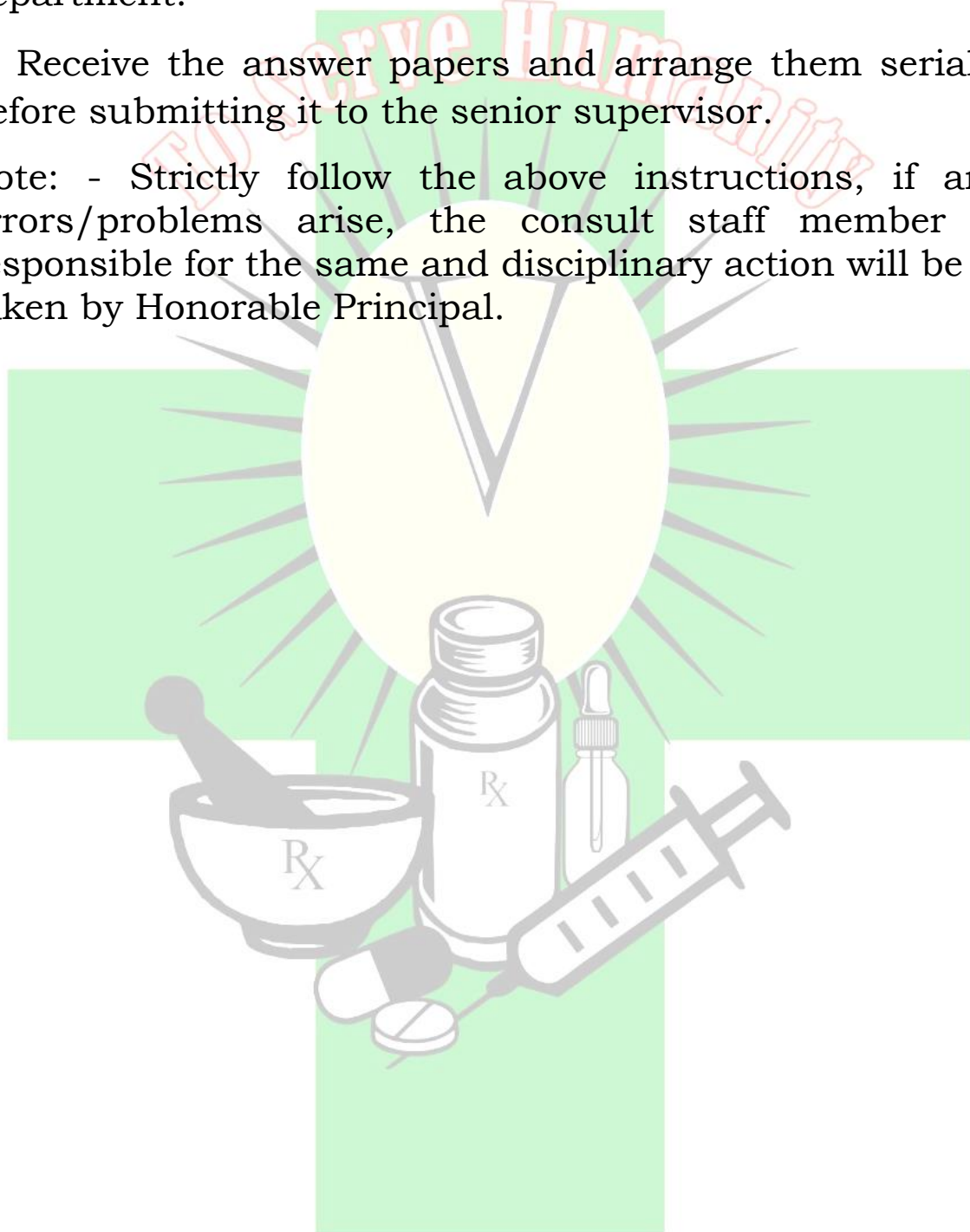

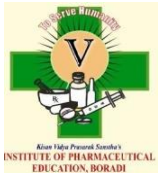

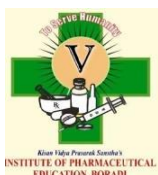


Code of Conduct for Supporting Staff
