The First Party is represented by **Mrs. Aparna P Patil**

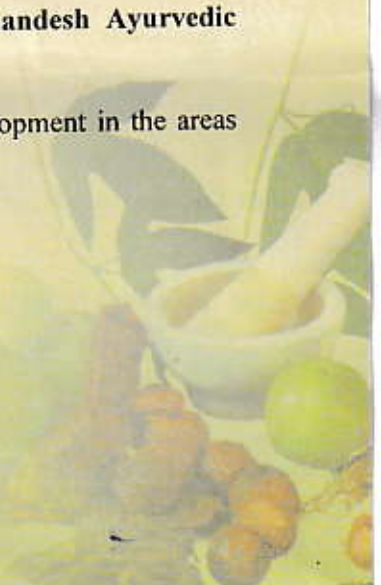
AND

- Desiring to club their efforts by pooling their expertise and resources intended to form a nucleus for promoting excellent quality manpower in the fields of pharmacy with special emphasis on advance analytical techniques and related fields etc.

NOW, THEREFORE, in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both KVPS Institute of Pharmaceutical education and **Khandesh Ayurvedic Pharmacy, Jalgaon**

Dr. Prakash H. Patil hereby acknowledges, **Khandesh Ayurvedic Pharmacy, Jalgaon** and KVPS Institute of Pharmaceutical education hereby agree to sign a memorandum of understanding (MOU).

ARTICLE-I: SCOPE OF THE MOU

This MOU details the modalities and general conditions regarding collaboration between

KVPS Institute of Pharmaceutical education and **Khandesh Ayurvedic Pharmacy, Jalgaon** for enhancing, within the country, the availability of highly qualified manpower in the areas of analytical technologies without any prejudice to prevailing rules and regulations in KVPS Institute of Pharmaceutical education and **Khandesh Ayurvedic Pharmacy, Jalgaon** without any disregard to any mechanism evolved and approved by both the Party. The areas of cooperation can be extended through mutual consent.

ARTICLE-II: SCOPE OF ACADEMIC INTERACTIONS

Both KVPS Institute of Pharmaceutical education and **Khandesh Ayurvedic Pharmacy, Jalgaon** shall encourage students / faculty through the following arrangements:

- a) Exchange of personnel through deputation as per the rules of the respective institute, for limited periods as mutually agreed upon;
- b) Organization of joint conferences and seminars;
- c) Practical training of KVPS Institute of Pharmaceutical education students at **Khandesh Ayurvedic Pharmacy, Jalgaon**.

Student may directly contact **Khandesh Ayurvedic Pharmacy, Jalgaon** on Individual basis or through KVPS Institute of Pharmaceutical education based on mutual consent

ARTICLE-III: SHARING OF FACILITIES

- a) KVPS Institute of Pharmaceutical education and **Khandesh Ayurvedic Pharmacy, Jalgaon** shall make provisions to share their respective important facilities in order to promote academic

and research interaction in the areas of cooperation based on case to case basis with respect to mutual consent on financial aspects.

b) **Khandesh Ayurvedic Pharmacy, Jalgaon** may allow KVPS Institute of Pharmaceutical education college students for project based internships subject to availability of facility with reference to project topic, Which will be purely on trainee basis without any monetary benefit to trainee.

c) KVPS Institute of Pharmaceutical education and **Khandesh Ayurvedic Pharmacy, Jalgaon** shall provide access to the library facilities to scientists, members of faculty and students as per the prevailing rules and norms in the respective institutes.

ARTICLE-IV: EFFECTIVE DATE AND DURATION OF MOU

a) This MOU shall be effective from the date of its approval by competent authorities at both ends.

b) The duration of the MOU shall be for a period of 5 years from the effective date.

c) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the students/faculty/scientists who have been admitted to pursue a programme under the MOU.

d) Any clause or article of the MOU may be modified or amended by mutual agreement of KVPS Institute of Pharmaceutical education and **Khandesh Ayurvedic Pharmacy, Jalgaon**
